NOW THIS DEED WITNESSETH AS FOLLOWS:

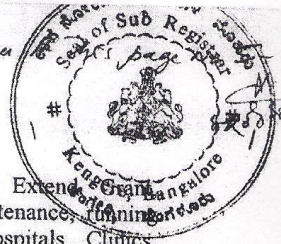
1. CREATION OF THE TRUST:

The founder has this day transferred and given to the trustees a sum of Rs. 1,00,000/- (Rupees one lakh only) to be held upon trust together with all the income arising therefrom and all the accumulations and accretions thereto for the intent purpose and objects herein contained.

- i) To establish, maintain, Develop, Run, Improve, Extend, Donate for and to aid in the establishment, Maintenance, development, improvement and extension of Hospitals, Clinics, Dispensaries, Medical Laboratorers, Research Units, with special emphasis on Medical Research in Modern Medicine including Indian systems of Medicine like Ayurveda and similar Institutions affording treatment, cure, rest, recuperation and other physically handicapped, the aged and the mentally retarded, with particular emphasis on the blind.
- ii) To establish, maintain, develop and donate for the establishment, maintenance and development of Blood Bank and Drug Banks.
- iii) To organize, Run and Assist in the organizing and running of free Medical Camps in Rural areas.
- iv) To do all that is necessary and incidental for the purpose of achieving the objects (i) to (iii) above.

C. RELIEF TO THE POOR & THE AGED: which without in any way taking away the generality of its meaning will include the following objects, namely.

- i) To Assist and provide for the poor by constructing community Halls, Rest Houses, etc., to conduct feeding of poor and to give food, clothing and cash grants to the poor and to grant donations for the support of the inmates of Orphanages, Rescue and Rehabilitation Centres and Similar institutions
- ii) To provide relief in times of Natural calamities like earthquake, Floods Famines, Contagious diseases by organizing Relief Camps etc.
- iii) To do all that is necessary and incidental for the purpose of achieving the objects (I) and (ii) above.
- iv) To establish old age Home.

D. OTHER OBJECTS OF GENERAL PUBLIC UTILITY:- Which without in any way taking away the generality of its meaning will also include the following objects namely;

6. **NUMBER OF TRUSTEES :** There shall not be less than 5 and more than 9 trustees.
7. **INVESTMENT OF FUNDS:** The powers of the Trustees as contained herein and generally shall be exercised in such a manner as to ensure that the investments of the trust funds shall be made only in accordance with the provision of section 11(5) of the Income Tax Act, 1961 and further the trustees will ensure at all times having due regard to the provision of section 13 and other relevant provisions of the Income Tax act 1961, that the Income of the trust will be exempt under the relevant provisions of that Act.
8. **IRREVOCABILITY:** the trust hereby created is irrevocable the provisions hereof may be amended if the trustees for the time being unanimously consent that the character of this Trust as a public Charitable Trust shall not be altered.

- 11. The trustees have power to co-opt other trustees in case of necessity for furthering the objects of the trust. The first trustees may decide upon the period for which such trustees are co-opted.
- 12. **VACATION OF OFFICE:** The Trustees may retire after giving a calendar months notice in writing of his intention to do so to each of the other trustees and upon the determination of such month, the trustee giving such notice shall ipso-facto cease to be the Trustees of the Trust.

The trustees may also vacate the office by death, resignation, insolvency or if convicted by a court of law from offence involving moral turpitude.




13. **DILEGATION:**



